#### **Target Audience**

The intended learner for this program is a licensed registered nurse or pharmacist with a minimum of 6 months employment as such, who possesses a basic understanding of cancer biology.

## **Course Requirements**

All the following requirements must be met

#### **General Information**

The ONS Chemotherapy and Biotherapy Course provides a comprehensive review of the knowledge needed to administer cytotoxic and biotherapeutic agents. The course content is appropriate for nurses who are new to chemotherapy/biotherapy administration in the oncology setting or for those who want a comprehensive review of this topic.

Nurses without oncology experience may not have sufficient background to place the information into context. They should consider a basic review course or self-study prior to attending. For nurses administering these drugs in non-oncologic settings, the Treatment Basics Course may be more appropriate.

# **Course Objectives**

Upon completion of the course, the participant will be able to:

- Identify various therapeutic modalities used to treat cancer with emphasis on chemotherapy and biotherapy.
- B. Describe the investigational process all drugs undergo to gain approval for use.
- C. Review ethical and legal issues related to cancer therapy.
- D. Identify factors affecting response to cancer therapy.
- E. Identify selected commonly used agents, their mechanisms of action, and any unique administration issues.
- F. Discuss safety precautions necessary when handling cytotoxic agents.
- G. Review chemotherapy dose calculations and practice examples.
- Identify nursing procedures and interventions for administering cytotoxic and biologic agents.

- Discuss two immediate complications of cancer therapy, extravasation, and hypersensitivity, and the nursing measures required to prevent and/or reduce these complications.
- J. Identify selected systematic side effects of cytotoxic and biotherapeutic agents and the nursing interventions required to manage these side effects.
- K. Review specific patient and family education that may prevent and/or reduce the impact of systemic side effects.
